

**University of Northwestern-St Paul / Life 102.5 Madison Cruise Giveaway**  
**OFFICIAL RULES for INSPIRATION CRUISES & TOURS**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.**

**1. ELIGIBILITY REQUIREMENTS:** Open to legal residents of the fifty (50) United States and the District of Columbia who are 21 years of age or older at time of entry. Employees, contractors, directors and officers of University of Northwestern-St Paul / Life 102.5 Madison and Inspiration Cruises & Tours, Inc.
